The regular monthly board meeting was called to order by Chairperson Steve Austin, at 6:00 PM at the Webb Lake Town Hall.

The Pledge of Allegiance was recited.

Roll call: Chairperson Steve Austin, Supervisor Greg Main, Supervisor John Kielkucki, Treasurer Wendy Purcell and Clerk Ken Busby were in attendance.

**VERIFICATION OF PUBLIC POSTINGS:** Busby stated the agenda was posted February 28, 2020 in three places and on the town website.

**CORRESPONDENCE:** No correspondence was commented on.

**REPORTS, DISCUSSION and ACTION**

**WEBB LAKE DISPOSAL AND RECYCLING CENTER RATES** – Kielkucki was interested in raising the rates to recoup some of the costs. Yearly is currently \$70, beds are \$5. Looking of raising the yearly \$10 this year and another \$10 for next year. Raise the mattresses to \$10 and Hide-a-beds to \$20.

**ROADS REPORT** – Roads Foreman Carl Meister reported the road bans could be put on next week. Had 80” of frost last year and only 60” this year. Permits to be obtained for new work. Wondering about sweeping the town roads. County roads will be swept after the snow is gone. Lake 26 Road will have the blacktop crushed by Washburn County. Kielkucki expressed hope that Lake 26 Road could be paved this year. Meister believed that would happen.

**FIRE DEPARTMENT STORAGE SHED** – Fire Chief Mike Hemquist stated the Fire Department building is full and need more storage. A 10’x16’ cold storage shed with a concrete sidewalk leading from the garage to the shed is being requested. Motion (Main/Kielkucki) to spend \$3500 for a new storage shed. Motion carried 3-0.

**APPROVAL OF FEBRUARY 3, 2020 MONTHLY BOARD MEETING MINUTES** – Motion (Kielkucki/Main) to approve the minutes. Motion carried 3-0.

**APPROVAL OF CLERK'S BILL LISTING:** Main had a couple questions. All were due to refunds. Motion (Kielkucki/Main) to approve the bill listing. Motion carried 3-0.

**APPROVAL OF TREASURER'S REPORT:** Purcell presented the financial numbers. Motion (Kielkucki/Main) to accept the Treasurer’s Report. Motion carried 3-0.
