## REPORTS, DISCUSSION and ACTION

**WAGNER SURVEYING MAP APPROVALS** – Mark Krause presented the new survey maps. Austin recused himself from voting. Motion (Kielkucki/Main) to approve the map #1 on the Webb Lake Campground. Motion carried 2-0. Motion (Kielkucki/Main) to approve the map #2 at Oak Ridge Inn. Motion carried 2-0.

**DESMOINES LAKE BOAT LANDING REPLACEMENT SIGN** – Temporarily tabled until Greg Main was on the line, but returned to the topic later in the meeting. Main spoke of replacing the sign. Motion (Main/Austin) to replace the sign. Motion carried 2-0.

**LOWER LOST LAKE DAM** – Report was emailed out to the board members. Busby mentioned a couple of general items. Road Foreman Carl Meister said he has been in discussions with the DNR and will be working with them.

EQUIPMENT, ROADS AND BUILDINGS – Scott Township asked the town to do some grader work instead of maintaining their own equipment. The roads in question are about 2.5 miles of road. Meister said he was agreeable to it. Austin agreed to doing Scott's roads that need grading and charging the same rate as the county. Looking into a new front end loader and dump truck with a rear wing and an underbelly blade. Austin opened the bids for the front end loaders. Most companies that submitted a bid were in attendance and explained their bids. Boyer submitted bid via email. Austin recommended all the information be parsed out on a spreadsheet before making a decision on a front end loader. Dump truck bids were opened next, quotes explained. Quotes will be considered and a decision made no sooner than March. Austin expressed that Meister's opinion on which equipment to buy would be greatly relied on.
