

TOWN OF WEBB LAKE

Monthly Board Meeting – November 1, 2021, 6:00 PM
Webb Lake Town Hall

The regular monthly board meeting was called to order by Chairperson Steve Austin, at 6:00 PM at the Webb Lake Town Hall.

The Pledge of Allegiance was recited.

Roll Call: Chairperson Steve Austin, Supervisor John Kielkucki, Treasurer Wendy Purcell and Clerk Ken Busby were in attendance. Supervisor Greg Main arrived shortly after the meeting started.

VERIFICATION OF PUBLIC POSTINGS: Busby posted the agenda on October 29, 2021 in three places and on the town website.

CHANGES TO ORDER OF AGENDA: No Changes.

CORRESPONDENCE: None

REPORTS, DISCUSSION and ACTION

WAGNER SURVEYING – Mark Krause presented a survey that was approved last month, but needed additional signatures. The board signed the papers. Also working on town roads for Crystal Drive and Shore Line Drive.

TOWN CREDIT CARD – Busby recommended the town use a credit card instead of a debit card for protection against unauthorized purchases. Motion (Kielkucki/Austin) to get a town credit card. Motion carried 2-0.

SPECIAL CHARGE TO PROPERTY OWNER – Busby explained that a property owner had dumped dock sections and other unacceptable items in the town brush pile last year. The \$800 bill for cleanup is unpaid as of this date. The town is allowed to put a tax lien on the property since it is refuse disposal. Motion (Kielkucki/Main) to put a property tax lien on the property owner in the amount of \$800.

EQUIPMENT, ROADS AND BUILDINGS – Road Foreman Carl Meister reported that Monarch has done the work on Bloom Rd and the helipad. Mack truck should be coming in next week. Would like to have a camera installed on the wing. The county has them and the town was able to test one out. The board is in agreement to allow the purchase. Austin and Purcell mentioned a washout on south Adams Lake Rd.

FIRE CHIEF REPORT – Chief Hemquist reported that the helipad was complete and it was tested right away with a live landing. The pilot mentioned that it was done well. Also want to propose buying a new combi-tool for extrication. Eventually buy a spreader and ram as well as funds allow.

APPROVAL OF THE OCTOBER 4 MONTHLY AND THE OCTOBER 23, 2021 SPECIAL BOARD MEETING MINUTES – Motion (Main/Kielkucki) to approve the minutes. Motion carried 3-0.

APPROVAL OF CLERK'S MONTHLY BILL LISTING: Motion (Kielkucki/Main) to approve the monthly bill listing. Motion carried 3-0.

APPROVAL OF TREASURER'S REPORT: Motion (Kielkucki/Main) to accept the treasurers report. Motion carried 3-0.

PUBLIC COMMENTS: Concern of Lake 26 Road near County Road H with the pontoons being so close to the road. Also concerned that the motel is not zoned properly for storing pontoons. Meister said he would talk to the owners to move them. Austin recommended checking with county zoning. Another person had a question on snow plowing stating that privately owned mobile home property shouldn't be plowed by the town. Austin mentioned that the mobile homes pay personal property taxes which allows the town to plow.

ADJOURNMENT: Motion (Kielkucki/Main) to adjourn. Motion carried 3-0. 6:28 PM.
