**Monthly Board Meeting – December 6, 2021, 6:00 PM**  
**Webb Lake Town Hall**

The regular monthly board meeting was called to order by Chairperson Steve Austin, at 6:00 PM at the Webb Lake Town Hall.

The Pledge of Allegiance was recited.

Roll Call: Chairperson Steve Austin, Supervisor John Kielkucki, Treasurer Wendy Purcell and Clerk Ken Busby were in attendance. Supervisor Greg Main attended via teleconference.

**VERIFICATION OF PUBLIC POSTINGS:** Busby posted the agenda on November 30, 2021 in three places and on the town website.

**CHANGES TO ORDER OF AGENDA:** No Changes.

**CORRESPONDENCE:** Invoice from exterminator. Thousands of flies and hundreds of Asian beetles were in the building this fall. Board decided to continue with the annual treatments.

**REPORTS, DISCUSSION and ACTION**

**CONSIDER AND ADOPT THE 2022 BUDGET FOR THE TOWN OF WEBB LAKE –** Motion (Kielkucki/Main) to approve the 2022 budget. Motion carried 3-0.

**NOMINATION OF ELECTION INSPECTORS –** Motion (Kielkucki/Main) to approve the 2022-2023 list. Motion carried 3-0.

**ST PATRICK’S DAY PARADE VENDORS –** Question of charging a vendor fee for someone to set up a booth on the town right-of-way. Decided not to have a fee at this time.

**RECYCLING HANDLING BY NWRPC DISCUSSION –** Busby explained advantages of switching the recycling portion only of the town’s refuse collection to Northwest Regional Planning Commission. The town would save \$14,000 based on the prior year’s expenses. Concern with the fact that Republic is the current company doing the collections for NWRPC. Austin wanted to get more info from all parties before deciding.

**EQUIPMENT, ROADS AND BUILDINGS –** Northern Lakes, Webb Lake Marine storage moved the boats, did not have the proper storage license. County will address. New Mack Truck on schedule for receiving mid-next month. Brush pile to be set on fire Tuesday, December 7. FD will be watching it.

**FIRE CHIEF REPORT –** Nothing reported.
