Monthly Board Meeting

January 8, 2024

Webb Lake Town Hall

The regular monthly board meeting was called to order by Chairperson Steve Austin at 6:00pm at the Webb Lake Town Hall.

The Pledge of Allegiance was recited.

Roll Call: Chairperson Steve Austin, Supervisor Greg Main (via teleconference), Supervisor John Kielkucki, Clerk Lisa Webster, Treasurer Wendy Schwartz were present.

VERIFICATION OF PUBLIC POSTINGS: Agenda was posted in three places and on the town website.

APPROVAL OF THE December 4, 2023, MONTHLY BOARD MEETING MINUTES: Motion (Main, Kielkucki) to approve board meeting minutes. Motion carried 3-0.

CHANGES TO ORDER OF AGENDA: No changes.

CORRESPONDENCE: Chairperson Steve Austin reported the Town filed court papers to be heard by the board of adjustments regarding the solar farm. Lisa Webster commented that the Wisconsin Town Association Board of Review will need to have recertification training in the upcoming months.

CERTIFIED SURVEY MAP APPROVALS: Wagner Surveying presented the Richard Hamilton property for rezoning. Mr. Hamilton would like to rezone the 10 acres west of the creek for resale purposes. Motion (Kielkucki, Austin) to approve rezoning. Motion carried 2-0.

REPORTS, DISCUSSION AND ACTION:

Equipment, Roads and Buildings: Carl Meister stated the snowmobile trail on Long Lake Road was moved to Shoreline Drive. The Snowmobile Club signed a contract releasing the Town's legal responsibility should an accident occur at this location.

An estimate from "Rent a Flash" and "SI Services" was presented for new signs entering the Town of Webb Lake. The sign will read as follows: Welcome to the Town of Webb Lake
Northwestern Wisconsin's Year-round Recreational Wonderland Population 437

Motion (Kielkucki, Main) to accept Rent a Flash screen printing bid of \$2,000. Motion carried 3-0.

The brush pile bid had decreased from \$16,000 to \$12,000 for chipping and removal. Further discussion will be had before moving forward on the project.

Fire Chief Report: Chief Mike Hemquist mentioned the compressor has been ordered and is expected to be delivered within a three month time period. The DNR would like to update the community wild and fire protection plan for Scott, Jackson and Webb Lake. The first meeting will be held at the Jackson Fire department on January 25, 2024.

Approval of Clerk's Monthly Bill Listing: Motion (Main, Kielkucki) to approve bill listing. Motion carried 3-0.

Approval of Treasurer's Report: Wendy Schwartz covered the monthly treasurer's report. Motion (Kielkucki, Main) to approve treasure's report. Motion carried 3-0.

General Township Communications: Next Town meeting will be Febuary 5, 2024.

Public Comments: Mike Sandeen stated the need for an additional employee for the summer months starting in April at the Recyling Center.
