2025 Private Road Snowplowing Contract Application

The town offers plowing to help our residents have access to basic services. You can seek out private companies as well, this is just a convenience service that the Township is providing as an option. The cost for Private Road snowplowing done by the Town of Webb Lake is \$175.00 per road, per season. The private road must meet the town requirements of 20 feet wide and 14 feet high when snow falls. *This means the road clearance must be maintained even after snow weighs down limbs and branches.* Failure to meet these requirements could cause damage to the town’s equipment and the town and any trees etc. Since this service is a privilege to have access to as a property owner, please see the hold harmless contained within.

- Minimum 4” of snowfall and the ground needs to be frozen for plowing to occur.
- Public Roads are plowed first, as is required by law. We will not put our road funding at risk by varying from this rule.
- The town is not a private contractor. We may not get to private roads until days after a large storm. Legally, the town has up to 14 days to clear public roads and there is no time limit for private roads.
- If you require faster or specific types of plowing service, you will need to make your own arrangements with a private contractor.
- If you are not satisfied with the town snowplowing of your private road, Webb Lake will refund your money and stop all future plowing of your road.

NOTE: The Town provides this service for private roads **not individual driveways.**

WHEREAS, the applicant and its group of property owners along the private road desires and wishes to hold harmless and indemnify the Town of Webb Lake and its successors and from any and all liabilities, losses, claims, judgments, suits, fines, penalties, demands or expenses, including, but not limited to, all reasonable costs for defense and investigation thereof (including but not limited to attorney's fees, court costs and expert fees) claimed by anyone by reason of injury or damage to persons or property sustained in or around the private road requested and work performed. The applicants acknowledge that they can seek out private companies to do the same and by executing this agreement they are bound by the hold harmless and other conditions contained within.
